

# 限聚指數 - 分析評論

#### **Group Gathering Prohibition Index – Commentary**

香港教育中心商會副主席任偉豪指出:「昨日澳門發現了可能是由大陸回澳的交流團所 引起的確診個案,即時作出了多項緊急應對措施。情況不禁令香港人懷疑,與大陸通關 是否安全。早前有些香港人認為,如果香港把疫情控制得好,就可以和大陸通關,經濟 就會好轉。但現在的情況是,大陸的情況似乎比香港還要危險,我們是否繼續要求和大 陸通關?」

Vice Chairman of The Hong Kong Chamber of Education Centres Yam Wai Ho observed, "Yesterday, Macau has newly confirmed cases that may be caused by a study tour returning from mainland China, so it immediately implemented a number of emergency measures. Hong Kong people may start to think whether it is safe to open the border with the mainland. Earlier on, some Hong Kong people thought that if Hong Kong controls the epidemic well, we could lift the border control with the mainland, and the economy would start to recover, but the current situation is that mainland's situation is more dangerous than ours. Do we still want to open the border?"
