香港民研發放今日最新限聚指數

摘要

香港民研早於2020年4月21日啟動「疫後復工指數」先導計劃,目的是提供科學數據讓市民開始討論應該在什麼條件下恢復正常生活,包括工作、個人、家庭、社區和社會層面。及至2021年4月7日,香港民正式研啟動了「限聚指數」,旨在每天公佈市民對「限聚令」的最新接受程度及市民可接受的限聚人數。在經歷幾個月的測試後,香港民研證實市民對「限聚令」的看法並不會急速改變。因此,香港民研決定每一至兩個月或在政策有改變時才進行一次基準調查,而每日的指數只需在最新基準調查參照表中,查閱每日的確診個案數字即可。今天(2022年9月23日)最新「限聚指數」數值為13.8,並有71%市民認為現時「限聚令」太緊。

最新基準調查樣本資料

調查方法 : 以電郵接觸群組成員,並於網上完成調查

訪問對象 : 十二歲或以上的香港市民

總成功樣本 : 3,821回應比率 : 4.5%

抽樣誤差[1] : 95%置信水平,百分比誤差+/-1%

加權方法 : 按照 1) 政府統計處提供的全港人口年齡及性別分佈、教育程度(最高就讀程

度)及經濟活動身分統計數字;2) 常規調查中的政治狀況評價及政治取向分

佈,以「反覆多重加權法」作出調整。

[1] 此公報中所有誤差數字均以 95%置信水平計算。95%置信水平,是指倘若以不同隨機樣本重複進行有關調查 100 次,則 95 次各自計算出的誤差範圍會包含人口真實數字。由於調查數字涉及抽樣誤差,傳媒引用百分比 數字時,應避免使用小數點,在引用評分數字時,則可以使用一個小數點。



分析評論



PORI releases today the latest Group Gathering Prohibition Index

Abstract

As early as 21 April 2020, HKPORI piloted the "Post-Epidemic Work Resumption Index (PEWRI, 疫 後復工指數)", which aimed to provide scientific data for people to kick start their discussion under what conditions should everyday life go back to normal, including work, personal, family, community and societal domains. Then on 7 April 2021, PORI officially launched an index called "Group Gathering Prohibition Index (GGPI, 限聚指數)", which aims to indicate people's latest acceptance of the "Group Gathering Ban 限聚令" on a daily basis, along with their acceptance of various prohibition limits. Since the public's view on the gathering ban has proven not to change rapidly after a few months' test, PORI has decided to run benchmarking surveys only once every one to two month or whenever there are changes in the policy. Daily index figures can be obtained simply by checking on the table of index values versus the number of confirmed cases as compiled from the latest benchmark survey results. GGPI stands at 13.8 today (23 September 2022), and 71% considered the current ban too strict.

All error figures in this release are calculated at 95% confidence level. "95% confidence level" means that if we were to repeat a certain survey 100 times with different random samples, we would expect 95 times having the population parameter within the respective error margins calculated. Because of sampling errors, when quoting percentages, journalists should refrain from reporting decimal places, whereas one decimal place can be used when quoting rating figures.

Commentary

Independent commentator KC Poon observed, "Since the outbreak of the pandemic in early 2019, all industries in Hong Kong have been suffering to various degrees as a consequence of the 'zero infection' policy. However, the long battle against the pandemic, with the economy and people's livelihood as collateral, and the stringent immigration policy, has caused irreversible damage to businesses in all sectors. In order to survive, viruses know how to show their vitality. In order for Hong Kong to integrate with the international community, we must also show our flexibility and adaptability to meet the ever-changing environment. Hong Kong's treasury is the result of the accumulation of generations of Hong Kong people, to fight the pandemic at any cost is like pouring money into the sea, and I believe it is not what Hong Kong people want."
